

SERVING DEKALB COUNTY THROUGH ITS AGENCES FOR 54 YEARS

UGF was organized and incorporated as a non-profit organization in October, 1958 so that local agencies would not have to spend time raising money and could spend more time providing services. With UGF conducting one big fundraising campaign each year, residents of the county could help support a wide variety of services and programs with just one gift to the annual UGF Campaign.


Now – 54 years later – UGF is still funding four of the original six agencies: Red Cross, Boy Scouts, Girl Scouts and the Salvation Army. A total of 10 agencies will be funded by UGF during 2013.

To become a new UGF member agency, an organization must meet specific criteria. Some of the criteria includes the following: must be a non-profit under IRS 501(C)(3) guidelines, have an active, volunteer board of directors, provide community service(s) based on documented need. These programs/services must be able to make a meaningful impact on a social problem and/or a special target population in the DeKalb County area.

In June of each year, the UGF board approves a tentative allocation for each approved agency and sets the Campaign Goal for the fall campaign. The goal is set based on the budget committee's recommendation after having reviewed agency requests.

In September, the Campaign kicks off. UGF conducts the annual fundraising drive with the support of the community and help from dozens of dedicated volunteers. Funds are disbursed to the member agencies on a monthly basis the following year.

UGF is governed by a 33-member all volunteer board and is audited annually by a local accounting firm. UGF-funded agencies help to make a difference in the lives of thousands of DeKalb County residents each year.

The ARC is also responsible for the operation of five Supervised Community Living Homes in Fort Payne. Three individuals reside in each home. Staffing is done on a twenty-four hour basis to help the individuals living in the homes achieve skills needed to function responsibly in the community. The ARC's goal is to help each individual with mental retardation to achieve the highest level of independence possible.


